This is the website of Galveston-Houston Immigrant Representation Project ("GHIRP"). We recognize that visitors to our site may be concerned about the information they provide to us, and how we treat that information.

GHIRP is committed to safeguarding your privacy online. Please read the following policy to understand how your personal information will be treated as you make full use of our website. This Privacy Policy describes the types of information we may collect when you visit our website. By using the website or services, you agree to the terms of this Privacy Policy.

### **Your information as related to our website**

We collect the domain name and email address (where possible) of visitors to our website, aggregate information on what pages consumers access or visit and information volunteered by the consumer, such as survey information and/or site/email registrations. The information we collect is used to improve the content of our website, not shared with other organizations for commercial purposes. GHIRP will never send you any unsolicited information, including email regarding offers or advertisements at any time. Persons who supply us with their telephone numbers and/or email online will only receive telephone or email contact from us with information regarding requests they have placed online.

If you supply us with your postal address online you will only receive the information for which you provided us your address. If at any time you do not want to receive email and/or phone calls from us, please let us know by sending us an email at the email address listed below. In your email please provide us with your name, phone number, and email address registered and we will make sure your name is removed from the list. You can opt-out from our SMS text messages at any time by replying STOP.

### **Technology and Security**

When you visit our website, we may collect certain information by automated means through the use of cookies. A "cookie" is a short piece of text that websites send to a visitor's computer or other Internet-connected device to uniquely identify the visitor's browser or to store information or settings in your browser. We also may use third-party website analytics tools (such as Google Analytics), that collect information about user traffic on the website. The use of cookies is an industry standard. Many major websites use cookies to provide useful features for their customers.



Most browsers are initially set up to accept cookies. If you'd prefer, you can set yours to refuse cookies. However, you will not be able to take full advantage of a website if you do so.
