# Our Mission and Core Values

The **Galveston-Houston Immigrant Representation Project (GHIRP)** is a team of dedicated lawyers and legal professionals committed to ensuring that every immigrant has access to high-quality, compassionate, and comprehensive legal representation.

Since our founding in 2020, GHIRP's mission has remained straightforward: to build a resilient and diverse community by providing holistic legal support and zealous advocacy for immigrants across the Galveston-Houston area.

Our work is grounded in the belief that every immigrant deserves a voice in their legal process. We affirm that safety and autonomy are essential for each person to reach their full potential, and we know that diverse and inclusive communities make us all stronger.



## Our Commitment to Immigrant Justice

For five years, GHIRP has stood on the front lines of immigrant justice, defending the rights of thousands of children, families, and individuals navigating one of the most challenging legal systems in the world.

We have seen firsthand the transformative power of effective legal representation. When immigrants are represented, they are empowered to build safer and more stable futures for themselves, their loved ones, and society as a whole.

Our commitment extends far beyond the courtroom. We strive to amplify the voices of immigrants, provide education and mental health resources, and foster a culture of belonging and resilience. In an era of shifting immigration policies and rising enforcement, our mission has never been more necessary. Legal advocates are an essential line of defense for due process, human dignity, and the pursuit of justice.

# Message from Our Executive Director

Dear GHIRP family, friends, and fellow immigrant advocates,

This year marks **five years of GHIRP**. Five years of standing with courage and compassion for immigrant communities across the Galveston-Houston region. What began around a dining room table has evolved into a movement driven by your trust, partnership, and conviction that every immigrant deserves dignity and protection.

In 2020, Liz, Vanessa, and I founded GHIRP with a vision to provide limitless advocacy for all immigrants in need. Our ideas and a handful of cases have grown into an organization of **42 fierce advocates** — attorneys, DOJ-accredited representatives, paralegals, social workers, and support staff — serving immigrants and families seeking safety and stability. This year, **GHIRP served 2,765 immigrants** in the community and **filed 1,959 applications on behalf of our clients**.

We are living in a historic moment where aggressive policies and the weaponization of bureaucracy are stripping vulnerable children and families of their sense of safety and unity. GHIRP has witnessed children placed on “rocket docket,” parents detained in predawn raids, and families forced to make unthinkable choices.

Human rights and due process violations are escalating at an alarming rate. Immigration authorities are detaining people in record numbers while eliminating the right to be released from detention. Individuals attending immigration court hearings are being arrested in courthouses despite following the rules. Detained children were awoken in the middle of the night on a holiday weekend in an attempt to unlawfully deport them in violation of child protective laws. At a time when legal representation is needed most, the administration is defunding lawyers and shutting down access to free legal information.

Despite all of this, our clients’ determination and resilience continue to drive our passion for zealous advocacy. GHIRP is responding by relentlessly fighting for our clients and litigating to uphold immigrant rights and the rule of law.

We are not alone. There is incredible hope in the rising resistance. The community — lawyers, teachers, doctors, social workers, elected leaders, and even neighbors — are standing up for immigrant children and families. Every time we choose compassion over complacency, I know that immigrant rights will persevere.

As we look ahead, we remain steadfast in our mission. **Protecting immigrant children and families is not a partisan issue; it is a human one.** Together, we will continue to advocate for justice, amplify the voices of immigrants, and build a future rooted in dignity and inclusion.

To our supporters, partners, families, and friends, thank you. Every dollar donated, every hour volunteered, every word of encouragement helps us move closer to the promise of justice for all.

# Transforming Lives through Advocacy

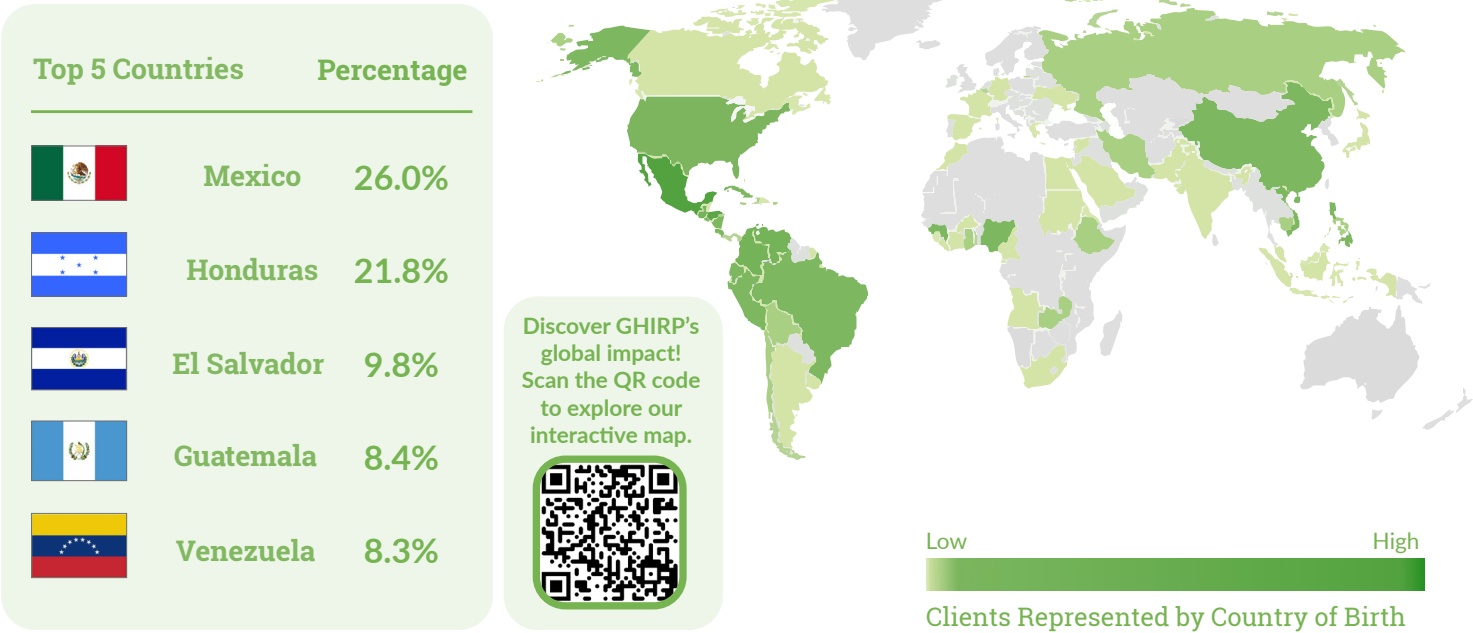
Since 2020, GHIRP has protected children, defended family unity, and ensured due process through advocacy, education, and zealous legal representation.

# A Brush of Hope

## “Lucía’s” Journey to Safety and Belonging (Client name changed to protect identity)

### Lucía’s Early Struggles

Lucía was just a child when her mother had to flee Central America to seek safety in the United States. Placed in the care of her father, she should have been protected and nurtured, but instead, she was left vulnerable to harm. Starting at a very young age, Lucia’s father often took her to work with him, where an older man began to hurt and threaten her. Despite Lucía’s desperate pleas for help, her father did nothing to intervene.

After continued threats, Lucia went to live with her aunt in a different city, hoping she would finally find safety. On the contrary, Lucía faced new and unimaginable hardships. Her caretakers abused her, refused to feed her, and neglected her basic needs. Her cousins physically beat her, and each day became a battle to survive.

By the time Lucía fled to reunite with her mother, she had endured years of neglect, abuse, and fear. Yet despite everything, she carried with her a quiet strength and an unshakable belief that her life could still change.

## The Power of Holistic Legal Representation During Uncertain Times

GHIRP began to represent Lucía shortly after she arrived, assisting her in seeking protection in the U.S. Lucía’s asylum interview was scheduled during a time of deep uncertainty for GHIRP. Federal funding for our Immigrant Children & Youth (ICY) Program had just been terminated, threatening our ability to represent unaccompanied children like Lucia.

Even so, our team refused to turn away our clients. With limited resources, GHIRP staff prepared Lucía’s asylum case, determined that her story would be heard.

While staff worked long hours under enormous strain, GHIRP’s interdisciplinary team ensured Lucía received trauma-informed care, consistent communication, and legal preparation for her asylum interview. Lucía bravely testified at her asylum interview, with her attorney, Abby, by her side. She was finally granted asylum, which protects her indefinitely from being deported to the harms she fled.

This **SUCCESS** is more than a legal victory; it’s proof of what holistic legal representation makes **POSSIBLE**.

“Lucía’s case was one of the most challenging I’ve assisted on due to the sensitive nature of her story,” shares Enzo, a GHIRP Supervising Paralegal. “Our team was facing an uncertain future due to funding and staffing changes, but after meeting her, I was determined to help ensure she had a fair chance. Her win, during one of the most difficult times in immigration law, reminds me how necessary our work is. I am proud of our client and our team for accomplishing this.”

### Healing Through Art and Hope

Beyond legal representation, GHIRP’s holistic approach helped Lucía begin healing. When asked if she needed any social services, her only request was for help finding art classes near her new home. Art became her way of expressing resilience and hope, and she even gifted paintings to her legal team, each one brighter than the last.

Today, Lucía is thriving in school and continues to use her creativity to tell her story and inspire others. Her journey represents the heart of GHIRP’s mission: that every immigrant deserves safety, dignity, and the chance to dream again.



# A Message from Our Client

**"Adrian"** (Client name changed to protect identity)

**2 months in detention (2022)**

**2+ years seeking safety**

**1 life changed = Asylum granted (2025)**

My name is Adrian. I am a 23-year-old with big dreams and goals. Growing up in Venezuela was extremely difficult. From a young age, I learned that survival took strength and determination. But the danger and persecution I faced eventually made it impossible to stay. To protect my life, I made the hardest decision: to leave everything behind.

Reaching the United States was not easy at all. I crossed the border near Tijuana, Mexico, in 2022 and was immediately detained. I remained in custody for nearly two months before being released in mid-December. I was then able to travel to Houston, where I hoped to finally find safety.

At the time, the fear did not go away. Not knowing whether I could stay in a place where I finally felt safe created constant anxiety. Everything changed when I connected with GHIRP, my incredible attorney, Liz Hoefer, and Sara Aguila (paralegal). For the first time, I felt seen and supported. They took my asylum case when others could not, and helped me access basic needs and education. They stood by me through every step, with respect and humanity.

Today, I am grateful. Grateful to God, to my legal team, and to every person who contributed to this victory. Now, I can look forward to a future where I am safe, a future where I can pursue an education, work hard, and achieve the goals I have carried with me since childhood.

To me, justice means peace — the peace that comes from being heard, protected, and treated with dignity. My message to others is: "Never lose HOPE. Even when life feels impossible, trust that change for the better is always possible. I am living proof."

# Five Years of Justice, One Unstoppable Community



## 2020

Chiqui Sanchez Kennedy, along with colleagues Liz Hoefer and Vanessa Perez, **founded GHIRP** with a vision to provide high-quality legal services to immigrants in the Galveston-Houston area.

For the first few months, GHIRP operated with minimal funding, working from Chiqui's dining room table and later from an office provided by her uncle at Foreman, DeGeurin, and DeGeurin while awaiting 501(c)(3) status.

## 2021

In January, GHIRP's application for **501(c)(3) status** was approved, enabling our small team to apply for funding and secure our future growth.

GHIRP received seed funding to provide Know Your Rights (KYR) presentations in Galveston at St. Vincent's House and to operate the HILSC Immigrants' Rights Hotline.

GHIRP opened the **Houston office** with a team of five staff members, providing free legal services to immigrants, including survivors of domestic violence, human trafficking, and individuals facing deportation.

Our Immigrant Children & Youth (ICY) Program grew tremendously, serving over 600 children in GHIRP's inaugural year.

## 2022

**GHIRP's legal team increased from 9 to 18 staff members**, including social services coordinators connecting our clients to resources in the community.

We solidified new partners and funders to support our "Universal Representation" model of legal services, representing individuals on a first-come, first-served basis for detained adults and unaccompanied minors.

The Department of Justice approved **GHIRP's status as a recognized organization** enabling us to provide representation through trained accredited representatives.





# 2023

GHIRP opened a **fully staffed office in Galveston**, finally giving a permanent home to our services on the Island to comprehensively respond to the community needs.

We joined a program with partner organizations to represent individuals who are eligible for US citizenship.

GHIRP's **Federal Litigation Program** took wings, representing immigrants in federal courts to protect due process rights such as wrongful deportations and unlawful, prolonged detention.

GHIRP expanded the Immigrant Children & Youth (ICY) Program by providing services to a second Houston-area facility for detained unaccompanied children aged 6-17 years old.

# 2024

GHIRP brought in its 4th year with a team of **38 bilingual employees**, all working together to provide holistic legal services to our clients.

We launched and expanded community facing programs such as **Friend of Court** (similar to an attorney-of-the-day court program) and **walk-in clinics** — programs that are now critical for informing people in the community about their rights and legal options.

GHIRP's Federal Litigation and Detained Adult Programs achieved a significant victory by securing the release of "Ana," a transgender client who experienced mistreatment, wrongful deportation, and discrimination while in detention. Our team supported her at every step of the way, and she ultimately won her case in 2025!

# 2025

GHIRP marks its **5th anniversary**, releasing the 2024–2025 Impact Report, highlighting key successes, powerful client stories, and the measurable difference made in the community. All of this was achieved during unprecedented challenges, which only strengthened our commitment to immigrant justice.

GHIRP has relentlessly advocated to protect due process and access to legal representation and information. As an organizational plaintiff, GHIRP joined nationwide lawsuits challenging the abrupt termination of legal programs funding lawyers for unaccompanied children and detained adults deemed mentally incompetent.

With continued growth and resilience, GHIRP remains a leading voice in immigrant advocacy, standing firm in its mission to ensure justice, dignity, and representation for all immigrants in need.

Our team at GHIRP believes that access to justice begins with access to knowledge. Over the past five years, GHIRP has hosted Know Your Rights (KYR) presentations, free consultations, and legal clinics throughout the Galveston-Houston area, reaching thousands of individuals and families. GHIRP proudly collaborates with schools, medical institutions, shelters, faith communities, and local government offices. This collaborative approach ensures that immigrants can access trusted legal information and resources where they live, learn, and work. We invite you to join us in this important work. Your support and partnership are crucial in our mission. Together, we're planting the seeds of empowerment, connection, and hope.

In 2024-2025, GHIRP's advocacy and client-centered work reached broader audiences through local, national, and international media. From breaking updates on harmful immigration enforcement actions to success stories uplifting the strength of immigrants in our community, news outlets turned to GHIRP for expertise and frontline perspectives. Our work was featured across a diverse range of digital, print, and broadcast platforms, ensuring that immigrant voices and urgent issues remain at the center of public conversations about justice and due process.



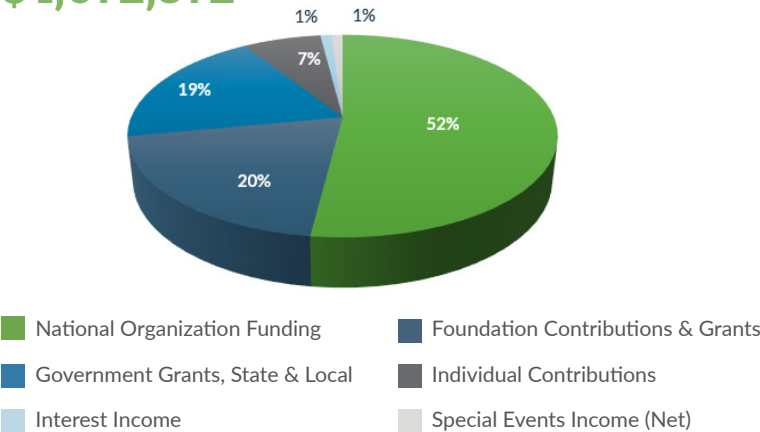

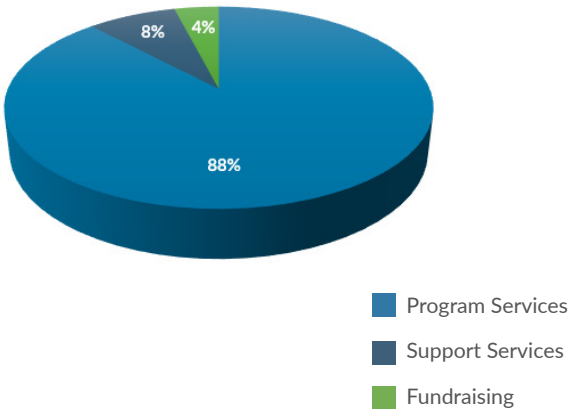


## Financial Overview

## Q&A Pro Bono Attorney: Diana Martinez, Associate, Hunton Andrews Kurth LLP

### Why did you choose to volunteer with GHIRP?

I chose to volunteer with GHIRP because their mission to advocate for vulnerable immigrants in the community aligns with my personal values. As a Houstonian and a child of immigrants, it is important for me to give back to the immigrants of Houston. I continue to volunteer with GHIRP because their strong guidance and legal expertise allows me to better serve my pro bono clients.

### Can you tell us more about your experience?

I worked on my first Special Immigrant Juvenile case through GHIRP, representing a mother and her two young daughters. Helping them navigate the court system, secure a favorable ruling, and move a step closer to legal status was truly rewarding.

### What does immigrant justice mean to you?

To me, immigrant justice means having a fair and reasonable chance to secure legal status and safety. It also means being treated with human dignity in the process.

### Why is pro bono representation important?

I believe it's an attorney's duty to do pro bono work, and it is important now more than ever given the heightened harsh and complex conditions that immigrants face across the world. In times when the rule of law and human rights are under threat, as they are now, it is critical to do one's part in ensuring immigrant justice is upheld.
